**CALL TO ORDER:** The meeting was called to order by the Chair, Stephen Schindler, and he stated that an executive session had been held prior to this meeting during which several potential litigation issues were discussed but no action was taken.

The Chair noted that all five Board Members were present constituting a quorum.

The Chair stated that before the Agenda was presented for approval he wished to clarify whether Director Stock had an item that he wished added to the Agenda. He stated that he had been made aware via an Email from Director Stock that he felt that Director Schindler had a conflict

of interest with all prior and potential future decisions made regarding the Delores Tunnel and requested that Director Schindler contact legal counsel regarding the matter.

Director Stock replied that he had no concerns.

Director Schindler stated that Mr. Kruse had responded to this question at the June 1999 Meeting and had stated that there was no conflict of interest.

The Chair requested approval of the Agenda as presented but the General Manager asked that Item E be moved to the position of Item C. The request was granted and the amended Agenda was then approved unanimously.
